**ADMINISTRATOR'S STATEMENT:**

Texarkana College (TC) is committed to advancing our community through attainable higher education and lifelong learning and to helping the state meet the goals set forth in the Building a Talent Strong Texas strategic plan. Since 1927, TC has provided higher education opportunities for Northeast Texas, one of the most under-educated regions in the state. TC is located in Bowie County which is the College's taxing district. TC's service area also includes Cass County and a small portion of Red River County, Texas.

TC offers programs that lead to Associate of Arts, Associate of Science, or Associate of Applied Science degrees, as well as Certificates of Graduation in occupational/technical fields. TC is the largest provider of dual credit courses in the region and a leader across the state, collaborating with fifteen Texas independent school district high schools and several homeschool programs. In addition, TC offers a robust selection of courses that serve our community and provide personal enrichment opportunities and development of skills through the Community & Business Education Division and also offers a full-service fitness center to students and the community.

Goals

As part of the institution's annual strategic planning, TC's Board of Trustees, along with faculty, staff, and administrators, have identified the following goals as top priorities for 2022-2024:

Annual Top Priorities:

1. Texarkana College will develop a financial stability plan in response to the current economic environment and will continue advocacy at the state level for increased support.
2. By fall 2023, the Texarkana College primary instructional format for academic courses will be in 8-week terms.
3. Texarkana College will employ highly qualified faculty and staff in an effort to better reflect the community and campus demographics.

In addition, the following goals will guide the institution's fiscal decisions as they relate to instruction, human resources, and institutional facilities:

- Texarkana College will increase fall enrollment for technical programs and annual contact hours for continuing education courses by 20% by end of the 2024 academic year compared to fall 2021.
- The Texarkana College Foundation will revise and expand scholarships to focus on recruiting new students to Texarkana College who would not otherwise be able to attend college.
- Texarkana College will complete capital projects to modernize campus instructional and common areas.
- Texarkana College will implement an enhanced communication module to enable two-way text messaging with students.
- Texarkana College will continue to be a Texas leader in completion rates by finishing each cohort in the top 25% for full-time students and top 50% for part-time students for all Texas community colleges.
- Texarkana College will develop a cohort mentorship for men of color to equip them with the necessary skills to be successful both inside and outside the classroom.
- The Texarkana College Foundation will reach \$15 million in assets by 2025.
- Texarkana College will investigate other credit and non-credit health care programs to produce entry level workers.
- Texarkana College will work with AR-TX REDI, Chamber of Commerce, City of Texarkana, TexAmericas Center, and other community partners to create new economic development opportunities.

SIGNIFICANT CHANGES IN POLICY:

There are no significant changes in policy which impact this budget request.

SIGNIFICANT CHANGES IN PROVISION OF SERVICE:

For the last four years, TC has maintained leader status among national and state community colleges. TC's students continue to rank among the top 10% of all Texas Community Colleges for full- time (FT) graduation rates.

Texarkana College serves rural communities in northeast Texas and the recent economic climate has impacted our students' access to affordable transportation and resources. To help alleviate barriers, and to off-set concerns surrounding COVID-19, TC has instituted new instructional modalities. All TC courses now have the ability to meet remotely through Microsoft TEAMS by means of online-on-a-schedule (OSS) or hybrid options. Our web-based and hybrid classes have improved delivery methods providing students with an easier course navigation experience and provide students with the best of both worlds: in-person interaction with enhanced access via TEAMS and the ability for students to attend class from any location. In addition, new student orientation has been converted to a virtual format enabling all students to better access vital information to help them start strong at TC. 100% of TC credit courses are taught from classrooms with distance education capabilities. Classrooms have been equipped with cameras and microphones to provide in-person and remote instruction simultaneously.

Federal Cares Act Grant funds received from the Department of Education have provided students with direct emergency financial aid grants to help cover expenses related to the disruption of economic stability and their need for reliable access to wi-fi and technology. The use of these funds has also been utilized by TC to cover the costs of implementing changes to delivery methods of instruction and testing along with enhanced safety measures, faculty and staff training, and sustainability of services and payroll expenditures during the strain of lost revenue caused by the pandemic.

The TC leadership team monitors Texas Success Center pathway data to better recruit underrepresented student populations into competitive, high-demand academic and skills training programs. As a result of the research that identified a great need in our area to help provide solutions to reskill and upskill our existing workforce, TC initiated a targeted plan to recruit non-traditional students to enroll in college. This plan included the establishment of a new scholarship program called "Just Start." The scholarship program, which began in Fall 2021, is funded by private donations to the TC Foundation. Awards are available for up to \$2,000 to help non-traditional students overcome barriers that have kept them from enrolling in college in the past and to help them pursue career goals. This effort supports regional economic development needs for a reskilled and upskilled workforce to meet competitive workforce demands. To date, more than 160 non-traditional students have benefitted from this new initiative.

A new online custom TC Application form was developed and launched in 2022. The new form significantly reduces the time for completion to 10-15 minutes compared to the standard Apply Texas form which takes students up to an hour or longer to complete. An online enrollment dashboard has been developed for new students to help guide students throughout the registration process.

The TC Foundation received a generous donation to fund the McCulloch Industrial Technology Center which is currently under construction with anticipated opening during Fall 2022. This center will be the home to 15,000 sq ft. of new training facilities for Electrical Technology program and HVAC and allowing for expansion of existing programs and addition of plumbing program in the near future.

Community engagement by faculty through our STEM division has enabled TC students to have increased field work opportunities through the Days Creek Watershed Restoration project with the City of Texarkana. Our students will be monitoring the watershed to document improvements in environmental quality over the next 5 years.

TC received designation as a national Achieving the Dream Leader College of Distinction in 2021 and was the recipient of the Texas Success Center's 2021 Texas Pathways Award- Excellence in Implementation and Scaling of Guided Pathways. In addition, TC received notification in June 2022 of continued regional accreditation as a result of a successful Fifth-Year Interim Review and an on-site visit by SACSCOC officials to off-campus instructional sites located on ISD campuses. No recommendations were made by SACSCOC.

**SIGNIFICANT EXTERNALITIES**

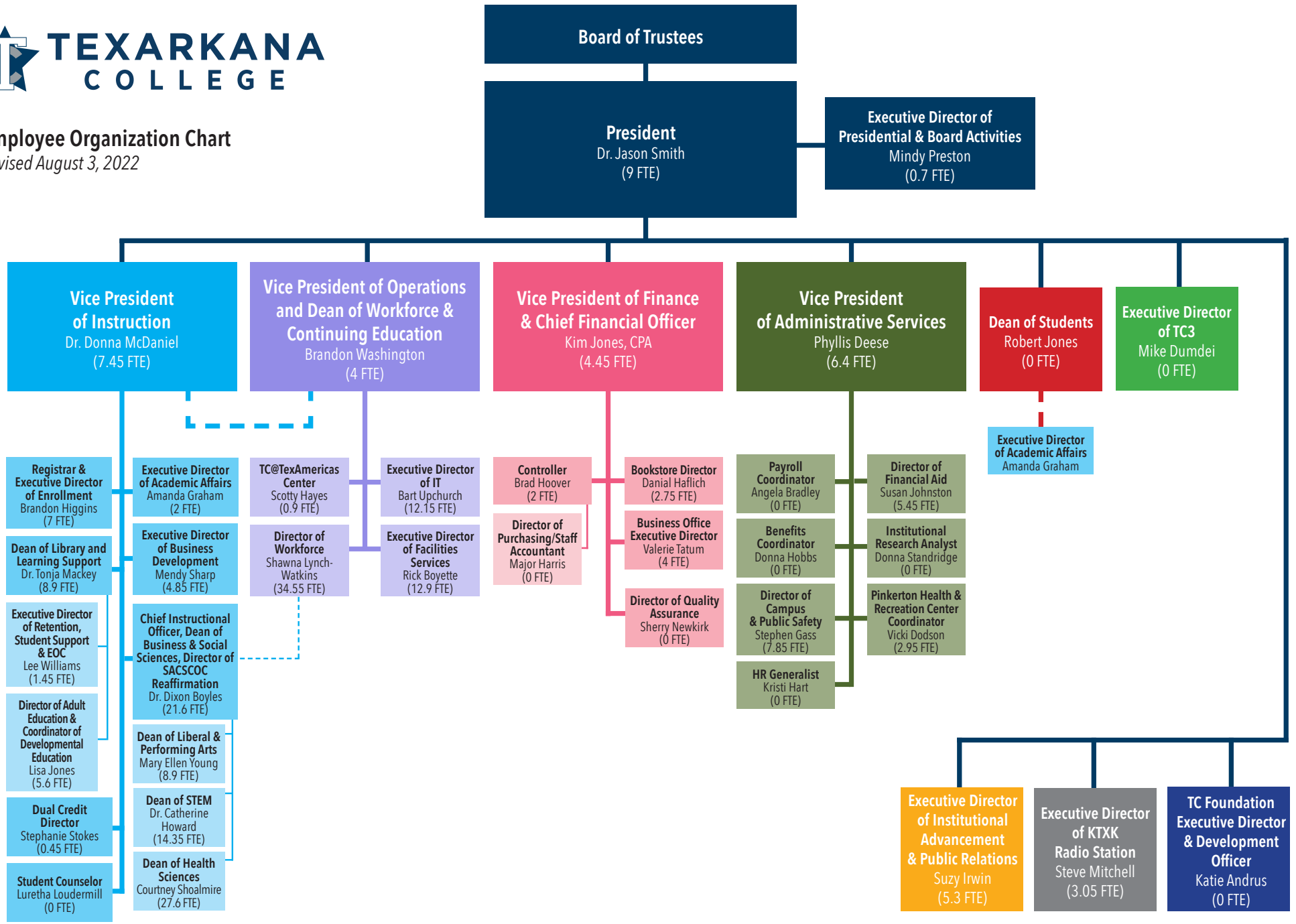
TC is committed to the economic strength of our regional and state economy and to the continued response to the needs of the local workforce. TC leadership team members serve on executive boards of economic development authorities and play an active role in urban planning and projections. The northeast Texas region is at the crossroads of three major interstates that support the development of infrastructure and exponential economic growth within the logistics, manufacturing, and transportation sectors. One of the largest rural industrial development initiatives in the USA, the TexAmericas Center, is located in Bowie County, TX, and provides potential land development resources of nearly 12,000 acres for industrial development. To respond to this opportunity, TC operates a technical training site on the property of the TexAmericas Center to accommodate economic development demand and the adjacent Red River Army Depot training needs.

Although the pandemic and current national economic instability has caused significant shifts in enrollment and revenue, TC remains vigilant to the needs of operating on a bare bones budget and has prioritized the development of a financial stability plan as part of our institutional strategic plan.

**SUPPORT FOR TEXAS ASSOCIATION OF COMMUNITY COLLEGES (TACC) FORMULA FUNDING REQUEST (per letter dated August 4, 2022)**

Texarkana College District respectfully supports the \$2,029.8 billion formula funding request submitted by the Texas Association of Community Colleges (TACC) in its letter to the Legislative Budget Board and the Governor's Office, Budget Division. This request is based on the recommendations of the Formula Advisory Committee of the Texas Higher Education Coordinating Board. State support remains critical to the district as it continues to fulfil its statutory role and mission to offer vocational, technical, and academic courses for certificate, transfer, and degree programs. Together with Texas' other 49 community college districts, we will continue do much of the heavy lifting in the state's efforts to achieve the Building a Talent Strong Texas strategic plan. Expanded state investments in community colleges will support dual credit courses that give high school students an early start in postsecondary education; initiatives to recruit uncredentialed Texans and support them through graduation; and the creation and expansion of programs built on the skills necessary for gainful employment and Texas' continued economic growth.

In June 2022, SACSCOC continued TC's regional accreditation because of a successful Fifth-Year Interim Review and an on-site visit.

To help alleviate barriers, all TC courses and new student orientation sessions can now meet remotely and 100% of TC credit courses are taught from classrooms with distance education capabilities.

In response to the state's Building a Talent Strong Texas strategic plan, TC initiated a recruitment plan for non-traditional students. In Fall 2021, a new scholarship program called "Just Start" was instituted and is funded through the TC Foundation serving more than 160 non-traditional students.

The TC Foundation is funding the construction of a new Industrial Technology Center opening during Fall 2022. This center will be the home to training facilities for Electrical Technology program, HVAC, and future programs in plumbing.

- TC will continue to be a Texas leader in completion rates by finishing each cohort in the top 25% for full-time students and top 50% for part-time students for all Texas community colleges.
- TC will increase fall enrollment for technical programs and annual contact hours for continuing education courses by 20% by end of the 2024 academic year compared to fall 2021.
- TC will develop a cohort mentorship for men of color to equip them with the necessary skills to be successful both inside and outside the classroom.
- The TC Foundation will revise and expand scholarships to focus on recruiting new students to TC who would not otherwise be able to attend college.
- TC will investigate other credit and non-credit health care programs to produce entry level workers.

We are incredibly grateful to have been selected as a recipient for the initial supplemental funds allotment and for the impact it made in our ability to retain our faculty and staff by meeting payroll obligations.

TC's taxing district along with our adjoining designated service areas are rural communities located in northeast Texas- one of the most underrepresented and undereducated regions in the state. Our prospective and current students have experienced great insecurity of wages, food, housing, and access to transportation that has significantly impacted their current decision to enroll in college. Higher wages in the retail, fast food, and service industry sectors have provided income community members needed immediately to help them get back on their feet post-pandemic and has delayed their current decision to enroll or return to college. As the regional, state, and national economy recovers from the economic downturn, we anticipate renewed enrollment.
